ungenerous treatment of investment in the electric grid which carries electricity produced by any type of energy source to businesses and households Given the great distance of the steadiest sources of wind and solar power from the largest energy consumers the economics of these cleaner sources depend on the further development of high voltage transmission lines and other features of the grid Yet the code continues to tax income realized from investments in high voltage power transmission lines more heavily than capital gains or most ordinary income
