

We the People

of the United States, in order to form a more perfect Union, establish Justice, insure domestic Tranquillity, provide for the common defence, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do hereby constitute in Congress assembled the following Constitution, in Ratification whereof, we, the undersigned Delegates of the States, have united our Votes and signed our Names, in Testimony whereof, we have hereunto set our Hands and seals the day and Year above written.

Article 1

Section 1. All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.

Section 2. The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and the Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch of the State Legislature.

No Person shall be a Representative who shall not have attained to the Age of twenty five Years, seven Years a Citizen of the United States, and when elected shall have been seven Years a Citizen of that State in which he shall be chosen.

The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and the Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch of the State Legislature. No Person shall be a Representative who shall not have attained to the Age of twenty five Years, seven Years a Citizen of the United States, and when elected shall have been seven Years a Citizen of that State in which he shall be chosen.

Section 3. The Senate of the United States shall be composed of Senators chosen by the Electors in each State, whose Number shall not exceed two.

Section 4. The Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch of the State Legislature. No Person shall be a Senator who shall not have attained to the Age of thirty Years, seven Years a Citizen of the United States, and when elected shall have been seven Years a Citizen of that State in which he shall be chosen.

Section 5. The Senate shall have the sole Power to try all Cases of Impeachment. When sitting for that Purpose, they shall be on Oath or Affirmation. The President shall have the Privilege of Speech, and shall not be questioned in respect to any Speech or Debate in either House.

Section 6. The Senators and Representatives shall receive Compensation for their Services, which shall not be increased during the Term for which they shall be elected. They shall, in all Cases, except Cases of Impeachment, be privileged from Arrest during their Attendance in either House, and in going to and from the same, and while they are so engaged in the Service of either House.

Section 7. All bills for raising Revenue shall originate in the House of Representatives; but the Senate may propose or concur with Amendments as to the Form of such Bills. All bills which shall have passed both Houses, except such as are in the Nature of Money Bills, shall, before they become Law, be presented to the President; and if he approve, he shall sign them; and if he disapprove, he shall return them, with his Objections, to the House of Representatives, by which they shall pass, or be rejected, or the Objections may be waived. If approved by the President, they shall become Law, as if he had signed them.

Section 8. The Congress shall have Power to lay and collect Taxes, Duties, Imposts and Excises, to regulate Commerce with foreign Nations, to borrow Money on the Credit of the United States, to define and punish Offences against the Law of Nations, to define and punish Offences against the Law of the United States, to punish Offences on the high Seas, and on the Land or Water within the Jurisdiction of the United States, to establish an uniform Rule of Naturalization, to establish an uniform System of Weights and Measures, to coin Money, to regulate the Value thereof, and to fix the Standard of Weights and Measures.
