    - Limitations on liability for non-economic losses and exemplary damages.
  - **Fraudulent court record, lien or claim against property:** § 12.002(b).
    - Greater of actual damages or \$10,000, court costs, reasonable attorneys' fees, and exemplary damages "in an amount to be determined by the court."
  - **Interception of communication:** §§ 123.004.
    - Statutory damages of \$10,000, plus actual damages in excess of \$10,000, punitive damages "to be determined by the court or jury," and reasonable attorneys' fees and costs.
  - **Civil theft:** § 134.005.
    - Actual damages, plus an amount not to exceed \$1,000, court costs, and reasonable attorneys' fees.
    - Actual damages not to exceed \$5,000 recoverable from a parent or person with the duty of control or reasonable discipline of a child.
